Dear Sir/Madam.

Thank you for your request for information relating to Emergency Housing.

You have requested the following information:

**A) The number of pregnant women who were given emergency housing in 2016/17 and 2017/18.**

2016/17- 79.

2017/18- 61.

**B) What type of emergency housing each pregnant woman was given?**

2016/2017-

Hotel/B&B = 57.

Temporary house = 22.

2017/2018 –

Hotel/B&B = 31.

Temporary house = 30.

Notes:

- No women were placed in hostel accommodation
- Hotel and bed and breakfast accommodation is recorded under the same category for our records

- Temporary accommodation will be a private rented property that our third party contractor has leased as temporary accommodation.

**C) The average length in weeks of the emergency housing.**

The average duration of length in emergency housing (in weeks) is 14 weeks on low end of durations and 57 weeks on the other end.

**D) Details of whether any of those pregnant women were given emergency housing more than once while still pregnant.**

**E) The number of pregnant women who were given longer-term housing after leaving emergency housing.**

For Questions D and E, we can confirm that we do not hold this information and are advising you as per Section 1(1) of the Act. This information is not recorded.
