 - (i) notify the Monitoring Officer of any disclosable pecuniary interests which I have within 28 days of becoming a member or co-opted member of the Parish Council; or
 - (ii) disclose a disclosable pecuniary interest to a meeting of the Parish Council where to my knowledge I have such an interest in a matter being considered at the meeting and where the interest has not been entered onto the register of interests; or
 - (iii) notify the Monitoring Officer of a disclosable pecuniary interest within 28 days of the date of a disclosure at a meeting as set out in (ii) above unless the interest is the subject of a pending notification; or
- (b) Without reasonable excuse:
 - (i) I participate in any discussion or further discussion or vote or further at a meeting in connection with a matter in which I have a disclosable pecuniary interest or
 - (ii) I knowingly provide information which is false or misleading or am reckless as to whether the information is true or not misleading in connection with my obligations under paragraphs (a) (i), (a)(ii) or (a)(iii)
