If there is an investigation completed during the LADO process, it is almost always the case that the subject of the allegation will be interviewed, and their responses noted, to be fed into the LADO process. This is not always possible, for example, where a subject does not have an employer or a regulatory body.

There are exceptions, for example, where the subject is being prosecuted for a relevant offence and in those cases, the responses to the police investigation may be used to inform the LADO process.

At the end of the LADO process, the employer is asked to update the subject of the allegation regarding the outcome of any LADO process.
