Thank you for your request for information relating to COVID Local Support Grant and HAF Programme.

You have requested the following information:

1. Please could you complete the first tab of the attached spreadsheet with information relating to the number of children eligible for benefits-related free school meals in your local authority area at the census dates indicated.

Coventry City Council has received the following allocations for the grants in question:

- Winter Grant Scheme £1,723,835.51
- Local Support Grant £304,144.00

The Local Support Grant was extended beyond 04 June 2021 until 30 September 2021 and the allocation for the extension period was £1,216,576.13.

This funding was used to provide food support to children eligible for benefits related free school meals in three main ways. Firstly, vouchers were provided to school age children who were eligible or were about to become eligible for free school meals, to enable them to buy food during the school holidays. Secondly, children who were younger than school age but were identified as being in need of food support during school holidays were provided with funding to purchase food with. Finally, food parcels were provided by the city's network of food hubs to eligible families throughout the period of the grants.

The Holiday Activity and Food Programme did not commence until Easter 2021.

Easter school holidays (29/03/21 - 9/04/21)

Coventry City Council made available Home Activity and Healthy Breakfast packs, containing a range of breakfast items (estimated to provide 16 breakfasts) and four activity sets exploring the story, history and legacy of our City as we prepared to celebrate Coventry as the City of Culture 2021. The packs were packed and distributed by charities, Feed the Hungry UK and Feeding Coventry in collaboration with community organisations. Feed the Hungry worked with volunteers to pack the parcels and deliver them to 17 community centres and churches where families could attend to collect their pack in the days preceding the school Easter holidays.

Summer school holidays (22/07/21 - 31/08/21)

The Holiday Activity and Food Programme funding is being used during the Summer school holidays (22 July 2021 – 31 August 2021 to provide grants to local providers to offer Holiday clubs and activities for children in receipt of benefits-related free school meals. In total, 36 organisations received a grant to co-ordinate Holiday Clubs at approximately 50 sites across the City. Among them are community groups, culture/arts organisations, sports clubs, faith groups, youth organisations, schools, specialist SEND providers and childcare providers. Activities are available every weekday during the school holidays.

Between all Holiday Clubs, approximately four hours operating the Coventry HAF programme in Summer 2021, there are 950 days where the clubs are open.
