Thank you for your request for information relating to Handed back contracts involving residential care homes .

You have requested the following information:

Under the Freedom of Information Act, please could you provide me with information about the number of contracts between social care providers and the council that have been withdrawn from or handed back by the provider in each of the calendar years 2019, 2020, and 2021 to date.

Please provide a breakdown for each year (or part year) for the number of handed back contracts involving residential care homes (including specialist care homes and nursing homes) and the number involving care at home (in a client's own home), as well as a breakdown by numbers for younger adults (under 65) and older adults (65 and over).

If providers have given reasons for handing back contracts, please provide a breakdown of the reasons cited for each year.

If possible, please provide information about the number of people whose care is covered by the contracts that have been handed back by the provider in 2019, 2020, and 2021 to date. Please provide a breakdown for each year between care homes and at home care and between older and younger adults.

Please see the information below:

Older People care homes

2019: None

2020: One residential home with 12 bedded capacity. Refused registration to delivery regulated activity from the home location.

2021: One residential home with 20 bedded capacity. Keeping resident capacity to adequate levels, the significant challenges with Covid 19 and the owners retiring.

Learning Disabilities (LD)

2019: One 4 bed LD residential home. Closure (owner retired)

2020: N/A

2021: Two 4 bed LD residential home. Due to closures (provider was withdrawing from providing services in Coventry)
