

**Notice of Intent**  
**Proposed New & Changes to Controlled Pedestrian Crossing facilities**  
**Ringway Junction 7**

Notice is hereby given that, Coventry City Council ("the Council"), pursuant to its powers under Section 23 of the Road Traffic Regulation Act 1984 (as amended), intends to introduce new controlled crossing facilities (TOUCAN) and to upgraded existing controlled pedestrian crossings to TOUCAN crossing facilities as part of the Local Air Quality Action Plan proposals.

Due to the proposed change in road layout at Ringway Junction 7 these are shown for the purposes of identification only on the Plan below (Dwg Ref. CCC/J7T/0222) and should be referred to when considering this notice. The controlled crossing facilities (TOUCAN) will be located at:

<b>Road</b>	<b>Location</b>	<b>No on Plan</b>
Access road to Skydome	At the existing controlled pedestrian crossing located north of the junction with Croft Road	1
Croft Road	At the existing controlled pedestrian crossing located approximately six (6) metres northeast of its junction with Starley Road	2
Croft Road (left turn connector road leading to Ringway Queens anticlockwise on slip)	At a point approximately four (4) metres north of its junction with the Ringway Queens anticlockwise on slip	3
Ringway Queens anticlockwise on slip	At a point approximately four (4) metres southeast of its junction with Croft Road (outbound)	4
Ringway Queens clockwise off slip	At a point approximately six (6) metres southeast of its junction with Butts Road (outbound)	5
Ringway Queens clockwise off slip (left turn connector road leading to Butts Road outbound)	At a point approximately twenty four (24) metres east of its junction with Butts Road (outbound)	6
Butts Road	At a point approximately four (4) metres west of its junction with Ringway	7
Butts Road (left turn connector road leading to Ringway Rudge clockwise on slip)	At a point approximately five (5) metres southwest of its junction with the Ringway Rudge clockwise on slip	8
Ringway Rudge clockwise on slip	At a point approximately four (4) metres northwest of its junction with Butts Road (inbound)	9
Ringway Rudge anticlockwise off slip	At a point approximately three (3) metres north of its junction with Croft Road (inbound)	10

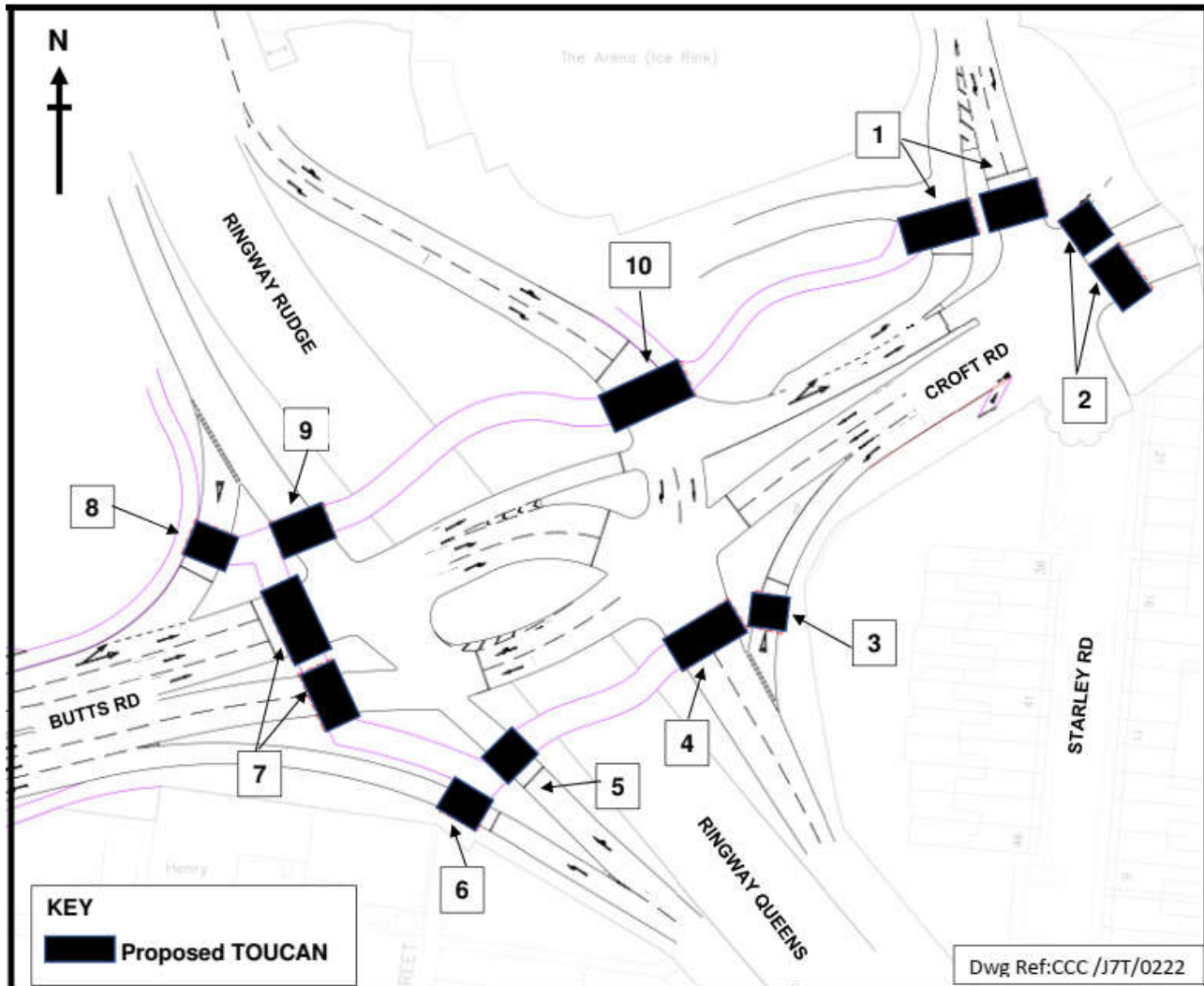
The proposed upgrades to the existing pedestrian crossing facilities and new controlled crossing facilities should assist both pedestrians and cyclists to cross the road as part of a route into and out of the City Centre and are part of the Local Air Quality Action Plan proposals. The works should be completed by the end of March 2023.
