

CITY OF COVENTRY (MIDDLEBOROUGH ROAD)
(TWO-WAY CYCLE LANE) ORDER 2022

Coventry City Council, in exercise of their powers under Sections 1(1), 2(1) and (2), 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act') as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order

1. This Order shall come into operation on the **XXth day of XXXX** 2022 and may be cited as the "City of Coventry (Middleborough Road) (Two-Way Cycle Lane) Order 2022".

2. i) In this Order

a) reference to an article followed by a number is a reference to the Article of this Order so numbered

b) "cause" includes permit and causing shall be construed accordingly

c) "enactment" means any enactment whether public, general or local and includes any order, bylaw, rule, regulation, scheme or instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of a subsequent enactment;

d) "vehicle" means:-

- i) a mechanically propelled vehicle intended or adapted for use on the road; and/or
- ii) a pedal cycle in actual use for the purposes of cycling
- iii) "vehicle", which shall for the avoidance of doubt include the whole or any part of a vehicle.

e) the following expressions shall have the meanings assigned to them:-

"pedal cycle" has the same meaning ascribed to it as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

"Relevant National Authority" means the Secretary of State in respects England;

"Road" shall have the same meaning ascribed to it by Section 142 of the Act

"the 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 and includes any enactment or re-enactment or amendment thereto

"Two-Way Cycle Lane" means a length of carriageway specified as a Cycle Lane in the First Schedule to this Order which is reserved for Pedal Cycles and is signed in accordance with the Traffic Signs Regulations and General Directions 2016 in which Pedal Cycles are authorised by a traffic regulation order to proceed in the same direction and in the opposite direction to other traffic;

- (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
3. Save as provided in Article 4 of this Order, no person shall cause or permit any motor vehicle to enter, proceed or wait in the lengths of road specified in Column 1 of the First Schedule between column 2 and column 3 other than for the purpose of crossing it
4. Nothing in Article 3 of this Order shall apply to any vehicle listed in the Second Schedule to this Order.
5. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.

FIRST SCHEDULE
Two Way Cycle Lane

Two Way Cycle Lane means a length of carriageway specified as a Cycle Lane which is reserved for Pedal Cycles and is signed in accordance with the Traffic Signs Regulations and General Directions 2016 and in which Pedal Cycles are authorised by Traffic Regulation Order to proceed in the same direction and in the opposite direction to other traffic		
Column 1	Column 2	Column 3
Location	From	To
Middleborough Road (southern side)	A point 77m west of its junction with Mill Street	A point 127m west of its junction with Mill Street

SECOND SCHEDULE

Nothing in Article 3 of this order shall apply to any:-

- (a) vehicle being used for police, fire or ambulance service purposes in the circumstances of an emergency.
- (b) vehicle being used in the service of a Local Authority for exercising any statutory powers or performing any statutory duties in the Cycle Lane
- (c) vehicle being used for:-
- (i) The removal of any obstruction to traffic
 - (ii) The maintenance, improvement or reconstruction of the length of road

- (iii) The placing, maintenance or removal of any traffic sign
 - (iv) The laying, erection, alteration or repair of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus.
 - (v) Building, industrial or demolition operations in or adjacent to the Cycle Lane
- (d) vehicle being used in accordance with any indication given by a traffic sign which has been placed pursuant to Section 66 or 67 of the Act.
