Thank you for your request for information relating to Roadworks and investment in roads.

You have requested the following information:

1. How many miles of road were worked on in your local authority area in the last three years?

- a. 2019/20: 13.37
- b. 2020/21: 19.67
- c. 2021/22*: 14.81

All data provided by financial year. Works included are planned resurfacing, patching and surface treatments. Reactive works (e.g. pothole filling and isolated works are not included).

NB* Due to recent financial year end, these figures are estimated based on latest costs using average treatment costs per unit of length.

2. How many miles of road were closed in the last three years in your local authority?

- a. 2019
- b. 2020
- c. 2021

This information is not recorded by the Council and therefore we are advising you as per Regulation 12(4)(a).

3. How many miles of road will be worked on in your local authority over the next 12 months?

2021/22: 14.03 (estimated)

Works included are planned resurfacing, patching and surface treatments. Reactive works (e.g. pothole filling and isolated works are not included)

4. How many miles of road will be closed in the next 12 months?

This information is not recorded by the Council and therefore we are advising you as per Regulation 12(4)(a). The Council do not know this information 12 months in advance. All utility works, our own works and Section 50 works are not known a year in advance and there is also no forecasting for this.

5. How much money has been invested in road improvements in the last three years? Please break down by years if possible.

2019/20: £2,440,851.02

2020/21: £3,256,136.67

2021/22: £3,642,361.50
