Thank you for your request for information relating to Low Traffic Neighbourhood scheme fines.

You have requested the following information:

I am writing to request information regarding fines issued in relation to breaches of Low Traffic Neighbourhood schemes or “LTNs” in your local authority.

LTN schemes sometimes go by different names in different areas, e.g. Active Neighbourhoods, Living Streets, Spaces for People. Here is a definition if helpful:

“A low traffic neighbourhood (LTN) is a residential area, bordered by main roads (roads that are often used by buses, lorries and non-local traffic), where through motor vehicle traffic is discouraged or removed, while allowing access for pedestrians and cyclists.”

Please could you provide me the following information regarding LTNs under your area:

1. The number of fixed penalty notices (or any other types of fine) issued to people for breaching Low Traffic Neighbourhoods in your local authority from May 2020 - Present;

Coventry City Council does not currently enforce any Low Traffic Neighbourhood schemes.

2. And the total value of fixed penalty notices (or any other types of fine) issued to people for breaching Low Traffic Neighbourhoods in your local authority from May 2020 - Present;

3. The total value of fixed penalty notices (or any other types of fine) issued to people for breaching Low Traffic Neighbourhoods in your local authority for the financial year 2021/22.

4. Please could you state how much revenue you expect to collect in the current financial year (or have forecasted in your budget) from fixed penalty notices (or any other type of fine) in relation to LTN breaches.

5. And how much it has projected or forecasted to collect from LTN breach related PCNs/fines in the next two financial years?

For Questions 2 to 5, these are not applicable. Please refer to Question 1.
