

CITY OF COVENTRY (ANTHONY WAY) (PROHIBITION OF DRIVING)
ORDER 2022

Coventry City Council, in exercise of their powers under Sections 1(1), 2(1) and (2), 124(1) and Part VI of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act') as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order

1. This Order shall come into operation on the 4th day of November 2022 and may be cited as the "City of Coventry (Anthony Way) (Prohibition of Driving) Order 2022".

2. i) In this Order

a) reference to an article followed by a number is a reference to the Article of this Order so numbered

b) "cause" includes permit and causing shall be construed accordingly

c) "enactment" means any enactment whether public, general or local and includes any order, bylaw, rule, regulation, scheme or instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of a subsequent enactment;

d) "vehicle" means:-

i) a mechanically and/or propelled vehicle intended or adapted for use on the road; and/or

ii) a pedal cycle in actual use for the purposes of cycling

iii) "vehicle", which shall for the avoidance of doubt include the whole or any part of a vehicle.

"pedal cycle" has the same meaning ascribed to it as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

"Road" shall have the same meaning ascribed to it by Section 142 of the Act

ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. Save as provided in Article 4 of this Order, no person shall ride or drive or cause or permit to be driven or ridden any vehicle, in any direction, in the length of Anthony Way from its junction with Binley Road to a point 10 metres north of its junction with Binley Road.

4. Nothing in Article 3 of this Order shall apply to any vehicle listed in the First Schedule to this Order.

5. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to


the provisions of this Order is without prejudice to the provisions of any other enactment.
