A summary of the proposed changes to the existing policy, for the academic year 2026/27 are as follows:

- The inclusion of two addition oversubscription criteria (criteria 3 and 10 in the draft policy) as highlighted below:

Oversubscription Criteria

- 1. Baptised Catholic children (see Note 2 below) who are looked after or previously looked after (See Note 3 below).
- 2. Baptised Catholic children (see Note 2 below) living in the catchment area of Christ the King Catholic Primary School who have a brother or sister (see Note 4 below) attending Christ the King Catholic Primary School at the time of admission.
- 3. Baptised Catholic children of a member of staff working for Christ the King Catholic School (See note 2 & note 6)
- 4. Baptised Catholic children (see Note 2 below) living in the parish of Christ the King Catholic Primary School.
- 5. Other Baptised Catholic children (see Note 2 below) who have a brother or sister (see Note 4 below) attending Christ the King Catholic Primary School at the time of admission.
- 6. Other Baptised Catholic children (see note 2 below).
- 7. Non-Catholic children who are looked after or previously looked after (See Note 3 below).
- 8. Non-Catholic children living within the catchment area of Christ the King Catholic Primary School who have a brother or sister (see Note 4 below) attending Christ the King Catholic Primary School at the time of admission.
- 9. Non-Catholic children living outside the catchment area of Christ the King Catholic Primary School who have a brother or sister (see Note 4 below) attending Christ the King Catholic Primary School at the time of admission.
- 10. Non-Catholic children of a member of staff working for Christ the King Catholic School (See note 6)
- 11. Other non-Catholic children living within the catchment area of Christ the King Catholic Primary School.
- 12. Other non-Catholic children living outside the catchment area of Christ the King Catholic Primary School.
- The inclusion of a note (note 6) which defines 'a member of staff working for Christ the King Catholic Primary School' as follows:
- "... Staff refers to any person employed by the Governing Body of Christ the King Catholic School on a permanent contract working a minimum of 15 hours per week".
