

**Notice of Intent**

**Proposed Installation of Controlled Crossings & Establishment of Cycle Track  
Binley Cycleway**

Notice is hereby given that, Coventry City Council ("the Council"), pursuant to its powers under sections 65 (1), 65(2) and 66 of the Highways Act 1980 (as amended) and of all other enabling powers hereby propose to introduce sections of Segregated Cycle Track along the following lengths of road:

Binley Road	from its junction with Brookvale Avenue to Brinklow Road
Brinklow Road	from its junction with Binley Road to Clifford Bridge Road
Clifford Bridge Road	from its junction with Brinklow Road to Mill Lane

Notice is also hereby given that, Coventry City Council ("the Council"), pursuant to its powers under Section 23 of the Road Traffic Regulation Act 1984 (as amended), intends to install controlled crossings on the following roads.

Binley Road	Puffin crossing on Binley Road, east of its junction with Princethorpe Way, at the existing Binley Road/ Princethorpe Way signal controlled junction
Binley Road	Cycle crossing on Binley Road at the existing Binley Road/ Princethorpe Way signal controlled junction. Cyclists able to request a signal change to hold back other traffic and permit them to cross in a southbound direction from the cycle track on Binley Road, opposite Princethorpe Way, into Princethorpe Way
Brinklow Road	Puffin crossing on Brinklow Road, northeast of its junction with Binley Road/Brandon Road at the existing Binley Road/Brandon Road/Brinklow Road signal controlled junction
Brandon Road	Puffin crossing on Brandon Road at the existing Binley Road/ Brandon Road/ Brinklow Road signal controlled junction
Brinklow Road	Toucan crossing on Brinklow Road south of its junction with Clifford Bridge Road at the existing Brinklow Road/Clifford Bridge Road signal controlled junction
Clifford Bridge Road	Puffin crossing on Clifford Bridge Road across the left turn lane into Brinklow Road at the existing Brinklow Road/Clifford Bridge Road signal controlled junction
Brinklow Road	Puffin crossing on Brinklow Road on the eastern arm of the junction at the existing Brinklow Road/Clifford Bridge Road signal controlled junction
Binley Road	Toucan crossing on Binley Road on the western arm of the existing Binley Road/Hipswell Highway/Allard Way signal controlled junction.
Hipswell Highway	Puffin crossing on Hipswell Highway at the existing Binley Road/Hipswell Highway/Allard Way traffic signal controlled junction

The works are part of the Binley Cycleway, a scheme proposed to connect the City Centre with the University Hospital Coventry & Warwickshire and encourage people to cycle. The works should assist to improve access and safety and be completed by the end of Spring 2023.
