

School's Early Years Funding Guidance

(with ref to Looked after Children and post LAC)

Preparing for termly school census
(Oct, Jan and May)



Procedures which are essential to maximize your school's Early Years Funding, includes:

- Communicating with parents the importance to ensure collection of data is in line with census dates
- Ensure the Early Years Parent Funding Agreements are fully completed and signed prior to census day
- Ensure parents are completing the section to claim for Early Years Pupil Premium, Disability Access Fund (if applicable) along with their consent.
- Ensure you submit the School Census file with the correct early years data

2 year old funding

- 2 Year Old Funding eligibility needs to be confirmed on the Coventry school's and Early Years Portal
- Parents can claim for a 2 year old funding code or schools can complete an assisted check

3 & 4 year old universal funding

- All 3 and 4 year old children in England are entitled to access up to 15 hours per week of funded early education, up to a maximum of 570 hours per year
- The early education entitlement place must be taken over no fewer than 38 weeks in any one year (1 September to 31 August)
- Children may take up a funded early education place from the start of the school term after their third birthday



30 hours Extended Entitlement

- Ensure that the 30 Hours funding codes have been applied for before:
 - 31st March
 - 31st August
 - 31st December
- 30 hour funded codes need to be reconfirmed every 3 months, the parents will be notified by HMRC to reconfirm the codes.
- A child cannot start a new 30 hour funded place in the Grace Period.

- For Looked after Children / Foster Carers a 30 hour code can be applied for via Early Years team, if they meet criteria



Making a Post Census/Headcount claim for an eligible 3 or 4 year old (PCH34)

- Schools must seek approval from the Local Authority, prior to adding a child onto the Coventry Schools and Early Years Provider Portal Amendment Task.
- **Please note; payment will not be made where approval has not been granted through this process.**
- To request approval, Schools will need to complete the online [PCH34 Online Application Form](#), which can be found on the Early Years & Childcare website pages, under the 'School led early years provision' section. Once we have received your PCH34 application you will be contacted by a member of the Early Years Business, Sufficiency and Funding team. Where approval is granted, the School will need to add the child's details to the **Coventry Schools and Early Years Provider Portal**, via the Amendment task, when it opens.



Disability Access Funding (DAF)

- Disability Access Funding (DAF) is additional funding that is paid directly to Early Year's Childcare Providers (including school Nursery Classes).
- It aims to support children with Special Educational Needs and Disabilities (SEND), who are aged 3 or 4 and in receipt of universal hours funding.
- The funding aims to facilitate childcare providers to
 - make reasonable adjustments to support children with SEND
 - access specialist training
 - purchasing specific resources to support your child
 - fund additional sessions etc.
- In order to be eligible, the child must be in receipt of **Disability Living Allowance** (DLA).

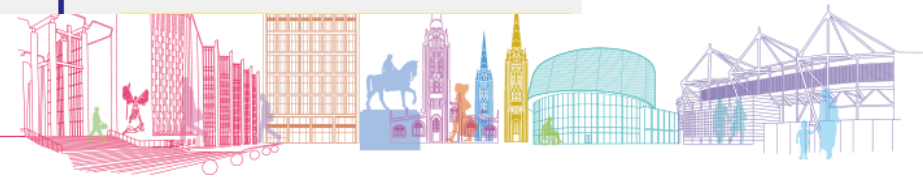

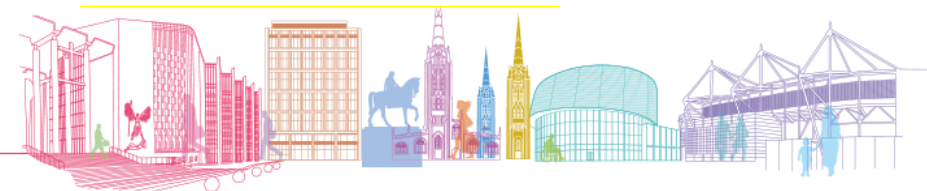
