CONSOLIDATION ORDER 2016 (VARIATION 12) ORDER 2023**

The Council of the City of Coventry (hereinafter referred to as "the Council") in exercise of the power conferred by Sections 1, 2, 3, 4, 5, 32, 35, 35A (1) and (3), 45, 46, 46A, 47, 48, 49, 51, 52, 53, 61 99, 100 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and by virtue of Section 74 and paragraph 8(4) of Schedule 8 of the Traffic Management Act 2004 ("the 2004 Act") in accordance with Regulation 21 special provisions for Consolidation Orders of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and of all other enabling powers the City of Coventry being a Civil Enforcement Area (CEA) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:

- 1.1 This Order is supplemental to the CITY OF COVENTRY(CITY WIDE)(PERMITTED PARKING AREAS AND SPECIAL PARKING AREA)(DESIGNATION, WAITING RESTRICTIONS, LOADING RESTRICTIONS, LOADING AREAS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2016 (as amended) ("the Original Order") which subject as hereinafter mentioned remains in full force and effect.
- 1.2 This Order shall come into operation on **XX<sup>th</sup> day of XXXXXX 2023** and may be cited as CITY OF COVENTRY(CITY WIDE)(PERMITTED PARKING AREAS AND SPECIAL PARKING AREA)(DESIGNATION, WAITING RESTRICTIONS, LOADING RESTRICTIONS, LOADING AREAS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2016 (VARIATION 12) 2023
- 1.3 The definitions are as set out in the Original Order save as varied by this Order
- 1.4 The restrictions imposed by this Order shall be supplemental to and not in derogation of any restriction or requirement imposed by the Original Order and any regulations made under the Act or by or under any other enactment
2. With effect from the date hereof the Original Order and the Map Tiles shall hereby be amended as follows:-
  - 2.1 Schedule 2 to the Order shall be removed in its entirety and replaced with the Schedule 2 attached to this Order.
  - 2.2 The attached new Map Tiles Plans shall be added namely:-

  - 2.3 The attached revised Map Tiles shall be added in place of the previous Map Tiles
