Thank you for your request for information relating to How often does the CCTV enforcement vehicle visit Coventry schools.

You have requested the following information:

1. Can you tell me how often each school in Coventry can expect to be visited by the enforcement vehicle (the one mentioned in the article or any other CCTV enforcement vehicle)?

There are more than 100 schools in Coventry and some schools have more than one access point to the school site. The enforcement car is used to enforce yellow zigzag 'School Keep Clear' restrictions outside of schools, it cannot be used to enforce single or double yellow lines. As some schools do not have any yellow zigzags 'School Keep Clear' markings e.g., Finham Primary School, we do not deploy the enforcement vehicle at these locations. Consequently, we do not prescribe a number of visits for each school.

2. Can you tell me how many tickets/fines for illegal parking, or any other offence for which a ticket/fine has been issued, have been issued as a result of a CCTV enforcement vehicle. If possible, can this be split by offence, location and date/time.

3. Does the CCTV enforcement vehicle issue tickets/fines for illegally parked, or any other offence for which a ticket/fine has been issued, when on the way to a school or on the

return trip.

The enforcement car is used to enforce the following restrictions, and these may be enforced when the vehicle is enroute to/from a school:

- School Keep clear (yellow zigzags)
- Red routes
- Bus Lanes
- Bus stop clearways
- Loading/unloading bays

The supply of information in response to a FOI/EIR request does not confer an automatic right to re-use the information.
