**Member Declaration of Interests**

**DECLARATION**

Please read this declaration carefully and then sign and date it.

I give notice that I have set out above, under the appropriate headings, my pecuniary interests which I am required to register under the Localism Act 2011 and the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and the Member Code of Conduct adopted by Keresley Parish Council. I have indicated appropriately where I have no such interests under any such headings.

I understand that, under Section 31 of the Localism Act 2011, if I am aware that I have a disclosable pecuniary interest in any matter to be considered or being considered at a meeting of the Council, which is not entered in the register or the subject of a pending notification, I must notify the Parish Clerk and Coventry City Council Monitoring Officer of that interest within 28 days of the date of the meeting.

I further understand that, under Section 34 of the Localism Act 2011, I may commit a criminal offence and, on conviction, be liable to a maximum fine of £5,000 and to disqualification as a member for up to 5 years if: without reasonable excuse, I fail to comply with an obligation to:

- notify the Clerk and Monitoring Officer of any disclosable pecuniary interests which I have within 28 days of becoming a member or co-opted member of the Council;
- or disclose a disclosable pecuniary interest to a meeting of the Council where my knowledge I have such an interest in a matter being considered at the meeting and where the interest has not been entered onto the register of interests;
- or notify the Clerk and Monitoring Officer of a disclosable pecuniary interest within 28 days of the date of a disclosure at a meeting as set out in above unless the interest is the subject of a pending notification;
- or notify the Monitoring Officer of a disclosable pecuniary interest within 28 days of becoming aware that I have such an interest in any matter which is to be dealt with by me in the course of my discharging any function of the Council as a member acting alone, unless the interest is the subject of a pending notification;
- or without reasonable excuse: I participate in any discussion or further discussion or vote or further at a meeting in connection with a matter in which I have a disclosable pecuniary interest or I take any steps in connection with a matter in which I have a disclosable pecuniary interest when discharging a function of the Council as a member acting alone, except for the purpose of enabling the matter to be dealt with otherwise than by me;
- or I knowingly provide information which is false or misleading or am reckless as to whether the information is true or not misleading in connection with my obligations above.
