**Freedom of Information Act 2000 (FOIA)**

Thank you for your request for information relating to school condition collection program.

You have requested the following information:

**1. A full list of the schools in your area which were surveyed during the 2017-19 Condition Data Collection Programme, and for each provide:**

The information provided below is in relation to schools where the Local Authority is the responsible body. For academy and free schools, the outcome of CDC inspection is given directly to academy trusts, and therefore the LA does not hold the information for academy schools.

**a. A breakdown of whether any element was given a C or D grade. Please provide a list of elements (these are Electrical service, mechanical services, external walls, roofs, site area, fixed furniture, floors & stairs, internal walls, playing fields, ceilings, redecorations and sanitary ware) given these grades and which of the grades given.**

Please note that CDC data is provided at a school level, with each element inspected being grouped within one of the above criteria, as such a criteria of C or D against mechanical services does not mean the overall condition of the mechanical services within the school is graded as C or D, but rather that a particular subset of the mechanicals within the school. As such, and the report generated from the data is not suitable for asset management purposes on its own, CDC data is less detailed than condition data held by schools or responsible bodies. This is because the report:

- Does not report on hazardous materials (e.g. asbestos)
- Does not address critical health and safety (H&S) requirements
- Does not assess a school's compliance with all statutory and legislative responsibilities
- Does not assess building capacity or suitability issues
- Does not propose remedial actions to address condition issues
- Does not include any cost information

**b. A breakdown of whether any element was given a 3 or 4 priority grade. Please provide a list of elements (these are Electrical service, mechanical services, external walls, roofs, site area, fixed furniture, floors & stairs, internal walls, playing fields, ceilings, redecorations and sanitary ware) given these grades and which of the grades given.**

We hold the information which you have asked for, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

This information is held in a non-reportable format and would require an officer to manually review each record to determine what information is held relevant to the request and collate the information. This has been estimated to exceed the 18-hour limit under the Act. This part of your request has been refused under section 12(2) of the Act.
