1. Introduction

This document sets out The Diocese of Coventry Multi Academy Trust (the Trust) Policy with respect to Admissions. The Trust is the Admission Authority for its academies. Each Academy Governance Committee is delegated to act in respect of admissions on behalf of the Trust.

Recognising their historic foundations, each academy will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the churches at parish and diocesan level.

Each academy aims to serve its community by providing an education of the highest quality within the context of Christian faith and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers to all its pupils.

In accordance with government legislation, each Academy Governance Committee consults with the Multi Academy Trust, Diocesan Board of Education, the Local Authority, other local academies, parents and other relevant persons in respect of its admissions arrangements.

2. Aims

The overriding aim of this policy is that it should work for the benefit of all children and parents/guardians in our area. It should be simple to use and assist parents/guardians to make the best decisions on the preferred academy for their children.

3. How Many Pupils will be Admitted (Published Admissions Number - PAN)

Every year the Trust will review and publish information concerning the academy's admission policy. This will confirm the maximum number of children to be admitted to the academy during the normal admissions round for the year of intake. This number is the Published Admissions Number (PAN). PAN therefore only applies to the usual points of entry in a school:

- Reception (primary or infant school)
- Year 3 (Junior school)
- Year 7 (secondary school)

If the number of applications is lower than the academy's published admission number, all applicants will be admitted. If there are more applications than places available then all applications will be given a priority from the oversubscription criteria and places will be offered in priority order.

The PANs for each of our academies is set out in the academy specific information in Appendix 1.

4. Priority Area

The priority area for each academy is set out in the academy specific information in Appendix 1.

5. Over-subscription Criteria

Children with an Education, Health and Care Plan that name a specific Academy will be offered a place first. This will reduce the number of places available at the Academy.

Where more applications have been received than places available or where to admit would conflict with the academy fulfilling class size legislation, the following priorities shall apply in order of the over-subscription criteria for each academy as set out in the academy specific information in appendix 1.

The definition of a sibling is:

- A child sharing the same parents;
- A half-sibling where two children have one common parent;
- A step-child, where two children are related by a parent's marriage or civil partnership;
- An adopted or fostered sibling.

6. Distance

If an academy is oversubscribed within any of the oversubscription categories, the determining factor will be the distance from the child's home address to the academy (priority being given to the shorter measurement).

Distance will be calculated by the Local Authority using a straight line measurement made using a computerised mapping system, from the centre of the applicants home address to the centre of the preferred academy as set by the Local Authority. All distances are subject to changes which may occur with updates of mapping data.

If two or more children with the same priority for admission live an indistinguishable distance from the academy, but cannot both be admitted, then the places will be decided by the drawing of names from a hat, and this will be independently overseen and verified by a governor or AGC member from another school.

The address for admission purposes is the place where the child is permanently resident with his or her parent or parents or legal guardian(s). Where a child lives with parents with shared responsibility, the home address will be considered to be the address where the child sleeps for the majority of the week. If the child spends exactly equal amounts of time with each parent or guardian, it is the responsibility of the parents to decide which address is the home address for admission purposes. Parents should not assume that a place will automatically be allocated to their child.

7. How to Apply for a Place at One of Our Academies

7.1 Normal Admissions Round Application Process

School places are available as follows:

- Reception school places (Primary or Infant Schools only) are available for children from the September following their fourth birthday.
- Junior school places are available for children from the September following their 7th birthday.
- Secondary school places are available for children from the September following their 11th birthday.

Application for the normal admissions round is via a Local Authority Common Application Form (CAF), which can be accessed and submitted online through the Local Authority Admissions Service website (see academy specific information in Appendix 1) or hard copies are available from the Local Authority or the academy. The Common Application Form should be returned to the Admissions Service by the date given by the Local Authority.

Applications from families moving into the area will be considered as on time if they are submitted and accompanied by proof of address by the date given by the Local Authority.

Late applications (i.e. those received after the deadline for the normal admissions round) will not be considered until after all of those which were received on time have been processed. The Academy cannot guarantee places for children when there are no places available as a result of late applications for the normal year of entry or any application that relates to a different year group.

Once an offer of an academy place has been made, it may only be lawfully withdrawn in very limited circumstances, which include an offer of a place based upon a fraudulent or misleading application. Where an offer of a place is withdrawn, an application may be made afresh, and a right of appeal taken up if an offer of place is refused.

Attendance at an academy Nursery does not automatically guarantee that a place will be offered in the Reception class of the academy unless specified in the academy specific information in appendix 1. Parents must apply for a Reception place in exactly the same way as parents of children not attending the Nursery. All applications will be considered against the oversubscription criteria in the same way regardless of whether the child does or does not attend the Nursery at the time of application.

*For Leigh CofE Academy, Harris CofE Academy and St Nicolas CofE Academy only, where parents wish to be given preference on the grounds of their faith within their application for a place at the academy they should complete the supplementary application form (see Appendix 2). This form must be completed at the same time as the Common Application Form and **returned directly to the Academy office.***

7.2 Children below Compulsory School Age and Deferred Entry to School (for entry to Reception Only)

Where a place has already been allocated in the Reception class, parents can defer the date their child is admitted to the academy until later in the academic year but not beyond the point at which they reach compulsory school age and not beyond the beginning of the final term of the academic year for which it was made. A child reaches compulsory school age on the prescribed day following his or her fifth birthday (or on his or her fifth birthday if it falls on a prescribed day). The prescribed days are 31 December, 31 March and 31 August. Where parents wish, a child below compulsory school age may attend part-time until later in the academic year but not beyond the point at which they reach compulsory school age. Once a place has been allocated, parents should make their wishes regarding deferment or part-time attendance clear to the Headteacher of the Academy.

In addition, the parents of a summer born child (those born from 1st April to 31st August) may choose not to send their child to school until the September following their 5th birthday and may request that they are admitted out of their normal age group – to Reception rather than Year 1. This request should be in the form of a written letter of application addressed to the Headteacher outlining the reason(s) why you wish your child to be considered for admission into a class outside of their normal age group. You should enclose any supportive evidence and documentation, for example from professionals who have worked with your child, that you

wish to be taken into account as part of that request. Each request will be looked at on an individual basis with any decisions taken according to what is considered to be in the child's best interests.

Parents should make the request to the Local Authority Admissions Service in line with the following deadlines so that the request can be considered and, where a request is not agreed by the academy, for the family to have adequate time to make an alternative application for a school place.

- **Warwickshire Admissions** - by 01 December of the year before the child turns 4.
- **Coventry** – at least one month prior to the published deadline for normal round applications.

Parents should still make an application by the date published by the Local Authority but must notify the Admissions Service on the application that they wish to request a place out of the normal age group.

Parents should submit to the Local Authority their reasons for wishing to defer applying for a school place. This should include confirmation of agreement to the proposal from the Headteacher of the Academy. On receiving the supporting evidence, and on the recommendation of the Headteacher, and agreement of the Academy Governance Committee, the Admissions Service will write to the parent to agree that the application can be processed for the following year.

The following potential risks / impact of deferral which should be noted:

- i) If an Academy agrees to a deferral, there is no guarantee that the child will be allocated a place at that academy the following year;
- ii) Should it not be possible to allocate a place at the Academy the following year, the Local Authority and the Trust will make every effort to allocate a Reception place, rather than a Year 1 place, but cannot guarantee that this will be possible.
- iii) Deferring entry will have an impact on a child's score should they sit the 11+ test. This is due to the age standardisation process.
- iv) When the child moves to a different school (e.g. primary to secondary, or to a different school due to a house move), the admission authority of the new school will be responsible for deciding which year group the child will be placed in. This could result in a child being required to 'skip' a year.

If a request for deferral is not agreed, the parent will receive a letter detailing the reasons why and a copy of the letter sent to the parent will be sent to the Headteacher of the Academy.

The parent may still change their mind regarding deferred entry by a whole school year, and submit an application in the normal way. If an application is received then the parent's previous request to defer until the following year would no longer apply. This will offer the following options to the parent:

- i) Their child starts school in the September following their 4th birthday;
- ii) They can consider deferring the child's start date in Reception until later in the school year;
- iii) They can discuss part-time arrangements with the allocated school, as detailed above.

A parent who chooses to defer entry by a whole school year will need to apply for a school place in the admissions round for the following year in the normal way. Their application will

then be considered in exactly the same way as all others submitted during that application year.

If a parent who has applied by the closing date given by the Local Authority later changes their mind and wishes to defer their child's entry to Reception, they should discuss this and other options with the Headteacher of the Academy. Requests to defer will not be agreed if the only reason is that a place has not been offered at one of the preferred schools.

7.3 Admission into a Class Outside of their Normal Age Group

Parents may seek a place for their child outside their normal age group, for example, if the child has experienced problems such as ill health or if they are moving from overseas and their child has not been educated in the English school system. This request should be in the form of a written letter of application addressed to the Headteacher outlining the reason(s) why you wish your child to be considered for admission into a class outside of their normal age group. You should enclose any supportive evidence and documentation, for example from professionals who have worked with your child that you wish to be taken into account as part of that request. Each request will be looked at on an individual basis with any decisions taken according to what is considered to be in the child's best interests.

Parents should make the request to the academy in good time, at least one month prior to the published deadline for normal round applications, so the request can be considered and, where a request is not agreed, for the family to have adequate time to make an alternative application for a school place before the published closing date.

These applications for admission outside normal age group will be considered alongside all other applications in accordance with the Local Authority co-ordinated admissions scheme. Parents have a statutory right to appeal against the refusal of a place at the academy for which they have applied. This right does not apply if they have been offered a place at the academy but it is not in their preferred age group.

7.4 In-Year Admissions

Parents should apply directly to the Local Authority Admissions service listed in the school details in appendix 1. If there are more applications than places available in the year group concerned (usually determined by the PAN), the Academy Governance Committee will apply the oversubscription criteria to all the applications and inform the Local Authority if a place is available. The Admissions Service will notify parents of the outcome.

8. Waiting Lists

In the normal admissions round, it is necessary to complete a Local Authority Common Application Form to apply for an academy place. Registering interest with the academy before the admissions round guarantees neither a place nor priority within the oversubscription criteria. Offers of places will be made by the Local Authority on the academy's behalf in the normal admissions round.

If the academy is oversubscribed following the normal admissions round, a waiting list will be maintained until December 31st of that year. The position on the list will be determined by applying the published over-subscription criteria and not by date of receipt. This will mean a position will change if a later application is received from someone with higher priority according to the over-subscription criteria. The existence of a waiting list does not remove the right of appeal against any refusal of a place from any unsuccessful applicant.

Names will only be removed from the list if a written request is received or if the offer of a place that becomes available is taken up or declined. The waiting list will close at the end of the autumn term (31st December). At that time parents of pupils on existing lists must confirm in writing their wish to be placed on a newly constructed waiting (or continued interest) list, which will operate for the remainder of that academic year. Non-receipt of written confirmation will result in not being placed on the newly constructed list.

9. Multiple Births

The Academy Governance Committee will give careful consideration to offering places above the Published Admission Number (PAN) to applications from individuals with parental responsibility for children whose twin or sibling from a multiple birth is admitted even when there are no vacant places and the twin or sibling has been given the last place in the year group.

If possible, places will be offered at the same academy to twins, triplets and children from other multiple births. For infant classes, a child whose twin or sibling from a multiple birth is admitted (other than as an excepted pupil) will be a legal exception to infant class size limits.

10. Equal Opportunities Policy

The admissions policy of the Trust is, while there are adequate places, to offer a place to all applicants irrespective of gender, religion, ethnicity or country of origin, disability or academic ability. Where applications exceed places available, offers will be made in accordance with the over-subscription criteria.

11. In year Fair Access (IYFA) Protocol

Each Academy Governance Committee recognises its duty to work with the Local Authority during the course of the year to provide fair access for “hard to place” children, even where the academy has already reached its published admission number – except where the infant class size limit of 30 pupils would be breached by doing so. These pupils may include children who have previously been permanently excluded from a school, children of Traveller families, refugees and asylum seekers, and children on the Child Protection register. The protocol established by the Local Authority for this purpose is designed to ensure that such pupils are shared equally between schools in an area.

12. Appeals Procedure

Parents have a right of appeal to the Independent Admission Appeals Panel against the decision of the Academy Governance Committee to refuse application for an academy place. An Independent Admission Appeals Panel will be arranged by the academy and details of the appeals procedure are available on the Trust website under Admissions here: <https://www.covmat.org/multi-academy-trust-policies/>

If you believe the admissions arrangements contained within this policy are not compliant with the Schools Admissions Code, an objection should be submitted to the Office of the School's Adjudicator (OSA) at osa.team@osa.gsi.gov.uk

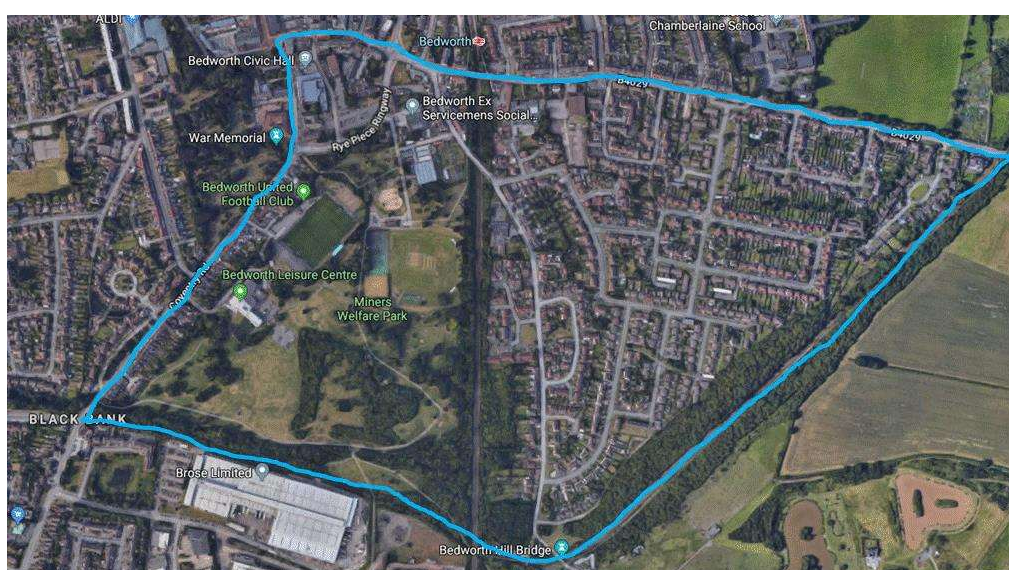
All Saints Bedworth CofE Academy

Published Admissions Number (PAN) for admission into Reception – 30

Local Authority - Warwickshire County Council

Priority Area

The area between Coventry Road, High Street, King Street, Bulkington Road (all roads inclusive), the Coventry Canal to Coalpit Fields Road and along the route of the disused mineral railway to the Black Bank Public House.



Over-subscription Criteria

a) Looked After Children

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order including those who appear [to the admission authority] to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

b) Siblings who live in the priority area of the academy

A child is considered in this category if a sibling is attending the academy at the time of application and will continue to do so at the time of admission i.e. at the start of the new academic year, and where the child lives at the same address as the sibling and is living within the priority area of the academy. Priority is **not** given if the sibling attends a nursery unit linked to the academy.

- c) Children in the priority area who have a sibling at the academy nursery at the time of admission.
- d) **Other children who live within the priority area of the academy**
- e) **Siblings who live outside the priority area of the academy**
A child is considered in this category if a sibling is attending the academy at the time of application and will continue to do so the time of admission i.e. at the start of the new academic year.
- f) **Any other children not categorised above**

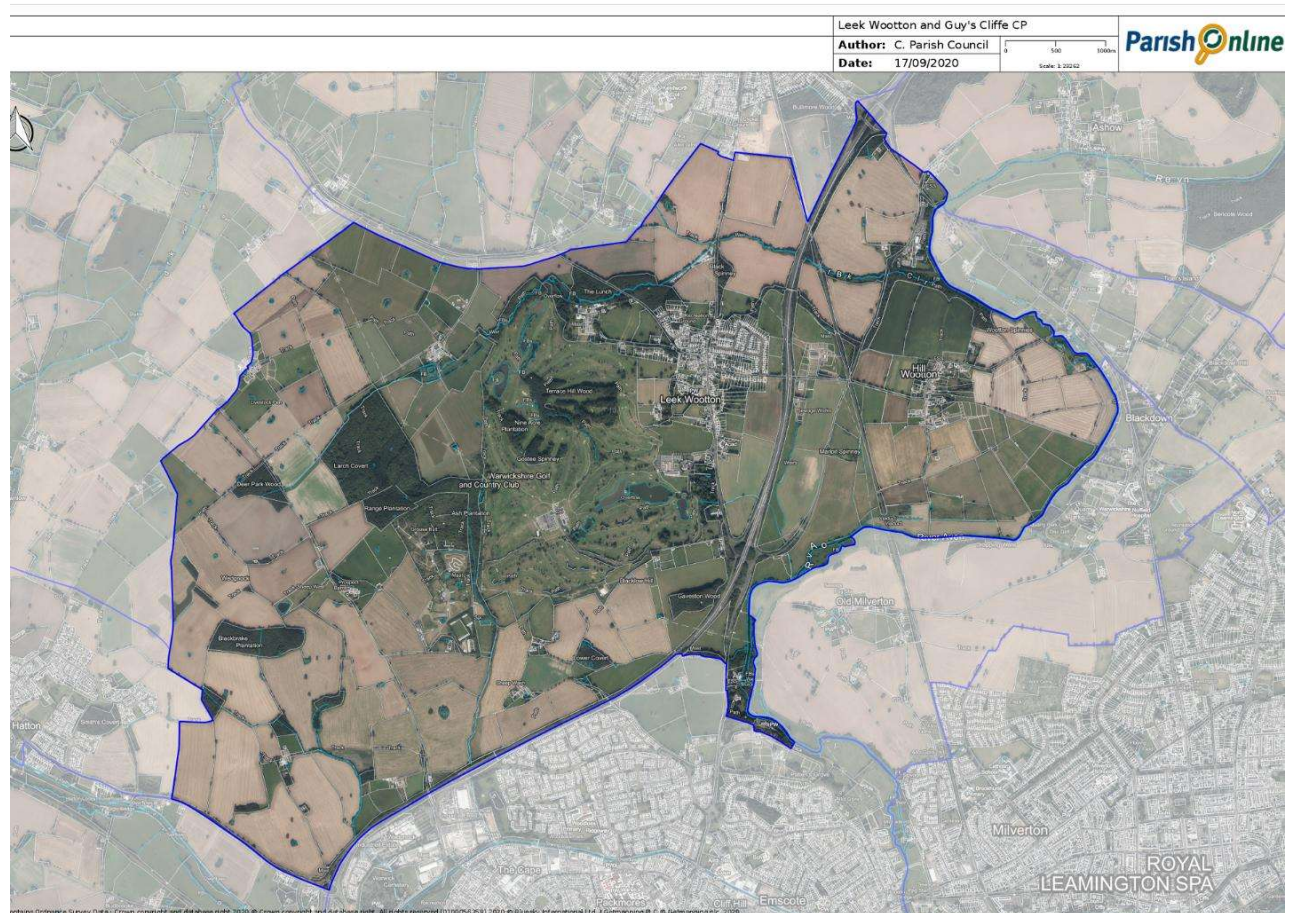
All Saints CofE Academy, Leek Wootton

Published Admissions Number (PAN) for admission into Reception – 20

Local Authority - Warwickshire County Council

Priority Area

The ecclesiastical and civil parishes of Leek Wootton and Guy's Cliff as defined by the following map.



Over-subscription Criteria

a) Looked After Children

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order including those who appear [to the admission authority] to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

b) Siblings

A child is considered in this category if a sibling is attending the academy at the time of application and will continue to do so at the time of admission i.e. at the start of the new academic year, and where the child lives at the same address as the sibling.

c) Other children who live within the priority area of the academy

d) Any other children not categorised above

Burton Green CofE Academy

Published Admissions Number (PAN) for admission into Reception – 15

Local Authority - Warwickshire County Council

Priority Area

Red Lane, Hob Lane and Hodgetts Lane to the Burton Green sign and Cromwell Lane to Westwood Heath Road junction. Families from farther afield also welcome, including Balsall Common, Berkswell, Kenilworth, Coventry and Solihull.

Over-subscription Criteria

a) Looked After Children

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order including those who appear [to the admission authority] to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

b) Siblings

A child is considered in this category if a sibling is attending the academy at the time of application and will continue to do so at the time of admission i.e. at the start of the new academic year, and where the child lives at the same address as the sibling.

c) Other children who live within the priority area of the academy

d) Any other children not categorised above

Dunchurch Boughton CofE Infant Academy

Published Admissions Number (PAN) for admission into Reception – 60

Local Authority - Warwickshire County Council

Priority Area

- The parish of Dunchurch excluding the northern areas from a line meeting the boundary of Long Lawford Parish (excluded) to include the Penthouse and to exclude the reservoir, crossing Coventry Road (A4071) at the narrow railway bridge and follows a line east to exclude Brickyard Spinney and Cawston Farm, including Fox Culvert and following the water course to cross Cawston Lane 9(included south of that point) and to exclude Cawston House running east to rejoin the boundary of the Dunchurch Parish excluding Little Scotland Farm.
- The parish of Thurlaston.
- The parishes of Grandborough and Willoughby, which are shared with Leamington Hastings CofE Academy.

Over-subscription Criteria

a) Looked After Children

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order including those who appear [to the admission authority] to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

b) Siblings who live in the priority area of the academy

A child is considered in this category if a sibling is attending this academy or Dunchurch Boughton Junior CofE Academy at the time of application and will continue to do so at the time of admission i.e. at the start of the new academic year, and where the child lives at the same address as the sibling and is living within the priority area of the academy.

c) Children who live in the priority area of the academy and who have attended Dunchurch nursery for a minimum of two terms.

d) Other children who live within the priority area of the academy.

e) Siblings who live outside the priority area of the academy

A child is considered in this category if a sibling is attending this academy or Dunchurch Boughton CofE Junior Academy at the time of application and will continue to do so the time of admission i.e. at the start of the new academic year.

f) Children who live outside the priority area of the academy and who have attended Dunchurch nursery for a minimum of two terms.

g) Any other children not categorised above

Dunchurch Boughton CofE Junior Academy

Published Admissions Number (PAN) for admission into Year 3 – 66

Local Authority - Warwickshire County Council

Priority Area

The parish of Dunchurch excluding the northern area from a line meeting the boundary of Long Lawford Parish (excluded) to include the Penthouse and to exclude the reservoir, crossing Coventry Road (A4071) at the narrow railway bridge and follows a line east to exclude Brickyard Spinney and Cawston Farm, including Fox Culvert and following the water course to cross Cawston Lane 9 (included south of that point) and to exclude Cawston House running east to rejoin the boundary of the Dunchurch Parish excluding Little Scotland Farm.

Also, the parishes of Thurlaston, Willoughby, Grandborough, Leamington Hastings, Birdingbury and Wolfhampcote.

Over-subscription Criteria

a) Looked After Children

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order including those who appear [to the admission authority] to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

b) Siblings who live in the priority area of the academy

A child is considered in this category if a sibling is attending this academy at the time of application and will continue to do so at the time of admission i.e. at the start of the new academic year, and where the child lives at the same address as the sibling and is living within the priority area of the academy.

c) Other children who live within the priority area of the academy

d) Siblings who live outside the priority area of the academy

A child is considered in this category if a sibling is attending this academy at the time of application and will continue to do so the time of admission i.e. at the start of the new academic year.

e) Children who live outside the priority area of the academy and who have a sibling attending Dunchurch Boughton CofE Academy or Leamington Hastings CofE Academy

A child is considered in this category if the sibling is attending one of these academies at the time of application and will continue to do so the time of admission i.e. at the start of the new academic year.

f) Children who live outside the priority area of the academy and who are currently in year 2 at Dunchurch Boughton CofE Infant Academy or Leamington Hastings CofE Academy.

g) Any other children not categorised above.

Harris CofE Academy

Published Admissions Number (PAN) for admission into Year 7 – 180

Local Authority - Warwickshire County Council

Priority Area

No geographical priority area.

Over-subscription Criteria

a) Looked After Children

A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order⁹¹ including those who appear [to the admission authority] to have been in state care outside of England and ceased to be in state care as a result of being adopted. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).

b) Children of permanent members of staff at the academy

A child who is the son/daughter of a member of staff (teaching and non-teaching).

c) Children with a sibling attending the academy at the time of entry

A child is considered in this category if a sibling is attending the academy at the time of application and will continue to do so at the time of admission i.e. at the start of the new academic year, and where the child lives at the same address as the sibling.

d) Faith related criteria

- i. The child is, or one of their parents is, a regular worshipper at a Church, who worships twice a month (which may equally include weekday and Sunday acts of worship) for a minimum period of 2 years
- ii. The child is, or one of their parents is, a regular but not frequent worshipper at a Church, who worships once a month at either a weekday or Sunday act of worship or attends a church activity (such as a Church Parade Service) which includes an element of worship, for a minimum period of 2 years.
- iii. The child is, or one of their parents is, an occasional worshipper at a Church who worships more than twice a year at either a weekday or Sunday act of worship or attends a church activity (such as a Church Parade Service) which includes an element of worship, for a minimum period of 2 years.

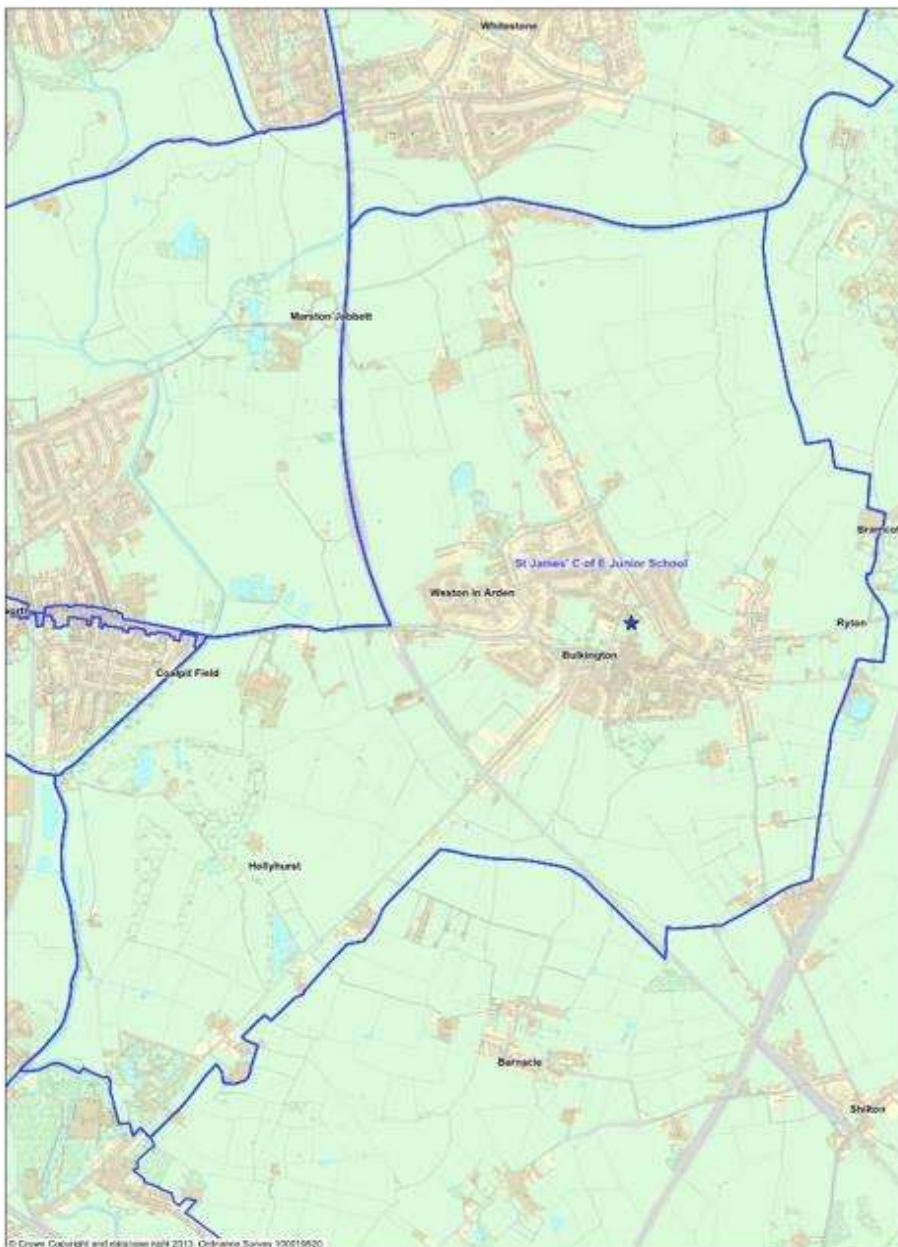

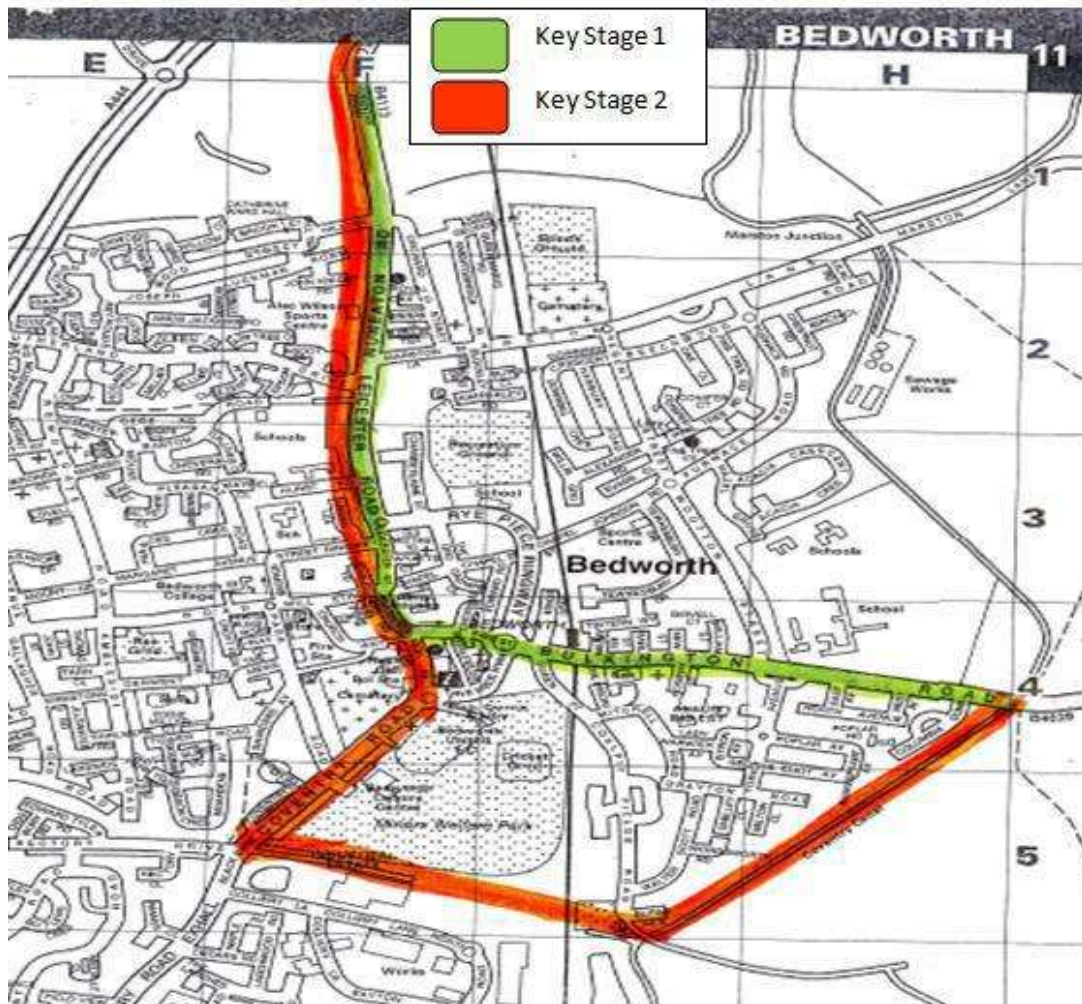
