Thank you for your request for information relating to Apprenticeship Levy.

You have requested the following information:

1. Is your organisation and apprenticeship levy payer? Yes or no is sufficient.

2. What was the value (\mathfrak{L}) of your organisation's apprenticeship levy contributions in (a) 2019-20 (b) 2020-21 (c) 2021-22 and (d) 2022-23. Please provide an annual breakdown.

2019-20 - £971,150 2020-21 - £1,011,125 2021-22 - £1,043,774 2022-23 - £1,108,283

3. How much apprenticeship levy 'expired' – i.e. was not used - in (a) 2019-20 (b) 2020-21 (c) 2021-22 and (d) 2022-23. Please provide an annual breakdown.

We confirm that no apprenticeship levy funds have expired from 2019 to date.

4. How many apprenticeship starts did your organisation create in (a) 2019-20 (b) 2020-21 (c) 2021-22 and (d) 2022-23. Please provide an annual breakdown.

2019-20 - 173 2020-21 - 130 2021-22 - 188 2022-23 - 147

5. How many of those apprenticeship starts created were (a) male and (b) female in 2019-20, 2020-21, 2021-22 and 2022-23. Please provide an annual breakdown for each gender.

2019-20 - 54 were male and 108 were female

2020-21 - 49 were male and 77 were female

2021-22 - 48 were male and 137 were female

2022-23 - 41 were male and 103 were female
