We hold the information requested, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

To clarify, this is not recorded in a reportable format and in order to identify the information required it would require an officer to review each individual SAR for every requested year to calculate the delay timeframe. Due to the number of requests received this will take over the allowed 18 hours under the FOIA.
