You have requested the following information:

**1. The information submitted by the local authority in response to the “waiting times” section of the initial reporting for the Department of Health and Social Care’s “Market Sustainability and Improvement Fund” for 2023 to 2024 (as required to be submitted by May 2023 by the DHSC in the provisional template described on the attached document.**

**2. The local authority's own most recent (to when this request is dealt with) measures of waiting lists and waiting times for adult social care support. Please provide all of whichever measures are used internally –for example covering waits for support, a care package, direct payment, and/or for assessment of needs/eligibility. If held, please also include a range of measures of these services, such as: Total number of people waiting; mean waiting time, median waiting time, 90th centile waiting time, maximum and minimum waiting times. Please specify the period of time each measure relates to.**

In response to your request, as at 13.12.2024 people waiting for long term assessment:

Total number of people waiting - 351

Mean - 167

Median - 96

Max days - 365+

During 2023 to date, people were waiting:

Mean days - 80

Median - 72

Max days 252
