All non recyclable mixed wastes were sent to landfill until January 2023 when the EA introduced legislation which prevented items containing foam and upholstery from this destination. From January 2023 all soft furnishings for disposal must be shredded and incinerated. Metals are extracted and recycled, the remaining elements are used for energy from waste
