Thank you for your request for information relating to mental health, careers & jobs and sustainability.

You have requested the following information:

#### **1. How many staff members are in your council**

5,163.

#### **2. How many mental health-trained staff members are in your council**

14 - mental health trained counsellors, doctors and nurses in the Occupational Health Service  
552 - Managers have had mental health awareness training from 1st April 2021 to 31st Dec 2023  
43 - Mental Health First Aider Responders in the workplace

#### **3. How many first aid-trained staff members are in your council**

The number of first aiders in any work area depends on risk assessment . We do not have a total figure across the Council, however we carry our area specific First Aid Audits to ensure Health and Safety compliance.

#### **4. How many council properties with solar panels installed this year**

Nine Council occupied buildings.

## **5. How many total council properties with solar panels installed**

39 Council occupied buildings.

## **6. How many total council properties with renewables installed**

39 Council occupied buildings.

## **7. How many council properties with renewables installed this year**

Nine Council occupied buildings in 2023 had solar.

## **8. How many RIDDOR reportable incidents in council properties**

From 1 April 2022 to 31 March 2023:

11 RIDDOR reportable accidents occurred our side, i.e. parks, pavements etc.

8 RIDDOR reportable accidents occurred in LEA schools

3 RIDDOR reportable accidents occurred on Council premises.

## **9. How many gas-related incidents in council properties**

None in the last twelve months.
