2. Has a digital solution already been procured? If so, who is the providing the platform?

This has just been awarded following a tendering process managed by our procurement team. The award has been made to Beebot AI Ltd.

3. Does the family hub system have integration with the council's current education, youth justice, or social care systems?

Our family hub system has some integration with the Council's education system (Capita One) and the social care system (EHJM module of LCS). It does not integrate with the youth justice recording system.

4. Who is the best person to contact around this area?
