Caludon Castle Library reduction of 3 hours on Wednesdays (2.00 to 5.00pm)

Earlsdon Library reduction of 14 hours - due to Community Managed

Finham Library reduction of 28 hours due to Community Managed

Arena Park Library closed - replaced by Holbrooks Library open 20 hours per week
