Managing effective services

We are all aware of the need to keep a close check on the money we spend as the cost-ofliving crisis continues, and the Council is not immune to these pressures either.

On top of being the most under-funded council per head of the population in the West Midlands – we should have an additional £31m a year just to reach the national average – inflationary pressures coupled with unprecedented demand on social care and homelessness services means all councils are facing tough choices to set the balanced budget we need to by law.

In all the time I've been a councillor I have never had to deal with the economic uncertainty we are facing today.

More information about these challenges is detailed in this issue of Citivision that explains how we will deliver a balanced budget for 2024/25.

Despite our financial challenges, we are determined to move forward and work even closer with other organisations in the city to ensure our services make a difference to the lives of local people and businesses.

We are always striving to help people struggling or in crisis, while at the same time working to boost the economic fortunes of the city.

It's always a challenge but something we are determined to continue to meet head on.



Tough choices to protect key frontline services

Coventry City Council has met its legal duty of setting a balanced budget after finalising plans taking more than 30 steps to either save money or generate extra income.

The Council has a £20million gap for the next financial year. The deficit has been created in part by a continued reduction in funding of the Council which receives more than £100million a year less in government funding than in 2010, meaning it receives the lowest funding per head in the West Midlands region.

If it was funded to the national average, it would receive an additional £31m a year. It's been made harder by sustained levels of increased demand on services. This can be seen by the fact that over the last 12 months, the Council has had to spend 79 per cent of its entire budget to meet its legal responsibilities in providing services in social care, housing and homelessness, up from 40 per cent in 2010. It means Coventry only has the remaining 21 per cent of its budget to spend on all other council services (see graphic below).



To generate additional income, Coventry will fall into line with neighbouring councils by charging for the collection of garden waste from April this year, and by increasing weekday city centre car parking prices – the first rise since 2017.

After listening to views during a consultation, plans to introduce charging for the first three hours of parking at the War Memorial Park will not happen, while only 70 per cent of streetlights could now be turned off overnight – meaning lights on main roads and busy junctions will remain on.

Tax levels will rise to 4.99%, a figure in line with most other local authorities, made up of 2.9% for the Council's own portion of the bill, plus the 2% precept required nationally to help fund the UK's gap in social care funding.

Social tariffs are broadband and mobile packages offering you reliable internet speeds at a discounted price.

They're to help reduce your monthly bills. Switching from

your provider's regular tariff to their social tariff will not incur any exit fees.

Some providers offer deals from as low as £10 per month, so switching could lead to a saving of around £202 against the average yearly cost of broadband.

Continued from front page >>> Councillor Richard Brown, Coventry City Council's Cabinet Member Finance and Resources, said:

"At a time when years of underfunding for councils is coming home to roost, we have worked incredibly hard to keep those cuts away from our residents as much as we can.

"But the reality is we can only go so far. Well-run councils such as ours are now struggling and there needs to be a new way of funding local government as the financial distress of councils in England

has its roots in a funding system that is broken.

"Coventry is a prudent council and, despite severe challenges, has been able to protect services while working to build a better Coventry for the future, and improve the quality of life for those who live here.

"Here in Coventry, 79p of every £1 in Council Tax we raise is spent on meeting our legal duties on social care or homelessness and housing, but we are facing the same challenges as councils across the country. "Although the recent national announcement of an additional £600 million to be shared by councils is welcome, recently a group of cross-party MPs that make up the Levelling Up, Housing and Communities Committee said an additional £4 billion is needed.



"That shows how these one-off monies are no more than a sticking plaster and not a lasting solution to the problem.

"If we don't get a more sustainable solution from ministers, we will be facing even harder decisions next year."

>>>> The ambition at Coventry Funeral Service is to keep things simple by streamlining the funeral arrangement process, with fully inclusive funeral packages, clear pricing and providing the necessary information for people to make the best decision for their loved one.

The issue of costs and bereavement poverty is well known, not just in Coventry but right across the UK, and this is a key driver behind why the service is being launched.

Cllr Patricia Hetherton, Cabinet Member, City Services, said:

"The Council is very conscious of the ever-increasing costs associated with funerals, and for many people this cost, can be unplanned, is expensive and may affect a family's ability to give their loved one a decent funeral. "Led by a very experienced funeral director, the aim is to help people in making the right decisions through clear, transparent pricing. It's also one of the key reasons why we've set up the Coventry Funeral Service."

A recent national report into funeral costs highlighted the average cost of a basic funeral is now around £4,100. This is a 4.7% increase in a year and reflects a staggering 126% increase in the last 20 years.

A Changing Places toilet also operates from the first floor of the Central Library.

Changing Places are toilet facilities for people with profound and multiple disabilities. They are fitted with specialist equipment such as a hoist and changing bench. It means families or carers will not have to worry about whether there are suitable toilet facilities when they go out shopping, plan a day out or travel.

Energy saving help for businesses

City centre scheme boost

A huge part of Coventry City Centre is one step closer to regeneration after an additional £12.24m was approved by the West Midlands Combined Authority (WMCA).

The money will be used to unlock the Coventry City Centre South scheme, and help transform outdated areas of the city, including Bull Yard, Shelton Square, City Arcade, and Hertford Street.

It brings the WMCA's total funding for City Centre South to £113m. Coventry City Council is contributing £32m.

The development, which covers 6.3 hectares of land within the city centre, includes 1,575 new homes. Of the 1,575 homes, at least 20 per cent will be classified as affordable housing.

New retail and leisure spaces, a community health centre and potential for a hotel with 150 rooms in the second phase also make up the regeneration plans.

The project, considered a strategically important housing



scheme, will start in 2024 and complete in stages, with the first homes expected to be occupied from 2027.

The first phase completion is expected to be 2031.

Developers The Hill Group and Shearer Property Group are working in partnership with Coventry City Council and the WMCA as the developers for the regeneration project.

Cllr Jim O'Boyle, Cabinet Member for Jobs, Regeneration and Climate Change for Coventry City Council, said:

"This is great news and the additional funding means that

the developer can now get on site and get cracking.

It will create a thriving, bustling new community that can help to support shops and restaurants and leisure attractions. It will also create jobs and apprenticeships which is good news too." Andy Hill, Group Chief Executive of The Hill Group, said:

"City Centre South is a oncein-a-lifetime opportunity to deliver a game-changing project that will rejuvenate the city centre."

Coventry helps lead inclusive cities drive

Coventry recently hosted a national programme building on the ways cities join up to support migration and diversity.

The Inclusive Cities programme, is run by the University of Oxford Centre on Migration Policy and Society (COMPAS).

Cities taking part include Belfast, Birmingham, Brighton, Bristol, Cardiff, Coventry, Glasgow, Liverpool, London, Newry, Mourne and Down, and Sheffield. The partnership of cities has shared plans to support the inclusion of migrants and longstanding residents across all aspects of life in its respective cities. Coventry has a good record of helping refugees and migrants to contribute to the social, civic, and economic wellbeing of the city. During the event Coventry delegates highlighted the positive contribution that migrants make in the city and reinforced their combined way of working.

Raising housing standards

A 12-week consultation has started on proposals to renew the Council's city-wide additional licensing scheme.

The scheme is to improve the management and living conditions for tenants of houses in multiple occupation. The consultation will give landlords, tenants and other residents the chance to have their say on how the Council plans to improve standards as well as on measures to reduce crime.

A house in multiple occupation, or HMO, is a property, or part of a property, shared by three or more people who are not members of the same family. Tenants usually share at least one facility such a as kitchen, sink or toilet. It can also include shared flats within a larger building.

Coventry has among the highest number of this type of property compared to other local authorities in England and Wales - around 6,800 or 26 per cent in the private rented sector. Cllr David Welsh, Cabinet Member for Housing and Communities, said:

"There are many good landlords in Coventry running private rented HMOs but there are also landlords who don't maintain their properties to the standard we, and local people, would expect.

"I hope people will take some time to have their say on this consultation."

Support if you are at risk of becoming homeless

Our housing and homelessness service deals with almost 200 approaches every week from people facing the prospect of becoming homeless.

Of the people who approach the service, some may just need general advice, but the majority will need an in-depth assessment and may then be entitled to help to prevent or relieve their homelessness. Cllr David Welsh, Cabinet Member for Housing and Communities, is proud of the Council's work on homelessness and said:

"We work hard for families searching for a home or

homeless families and single people all year round. The number of people who find themselves homeless, or at risk of becoming homeless is shocking really and it is a result of woeful underfunding nationally. We will continue to lobby for more money, while in the meantime working hard to help so many people."

If you are worried someone may be at risk of homelessness, they can self-refer online and the service will make contact with them to provide further advice.

Measles advice

Parents and carers are being reminded that two doses of the MMR (measles, mumps and rubella) vaccine provide the best protection against measles. If you or your child has not had the two doses of MMR ask at your GP surgery.

Speak to your GP if:

- a child in your family has missed their first or second dose of the MMR vaccine.
- you or someone in your family starts to show symptoms of measles.

For people who do not touch pork products there is a version of the MMR vaccine which does not use porcine in its production.

Children and young people across Coventry are being given the opportunity to help shape the direction of children's services in the city in a survey being carried out in schools.
