Thank you for your request for information relating to VLR scrutiny.

You have requested the following information:

How many times has any aspect of the VLR project been scrutinised by any of the Council's scrutiny committees and dates?

VLR falls under the remit of the Business, Economy and Enterprise Scrutiny Board (3). The information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'
