

**Notice of Intent**

**Proposed Installation of Controlled Crossings**  
**A444 Blue Ribbon Roundabout & John Wigley Way**

Notice is hereby given that, Coventry City Council ("the Council"), pursuant to its powers under Section 23 of the Road Traffic Regulation Act 1984 (as amended), intends to install controlled crossings on the following roads.

Foleshill Road	Toucan crossing on Foleshill Road at a point approximately 29 metres northeast of its junction with John Wigley Way replacing and relocating the existing controlled crossing (pedestrian)
Foleshill Road	Toucan crossing on Foleshill Road (outbound) at a point approximately 18 metres northeast of its roundabout junction with Jimmy Hill Way, replacing and relocating the existing controlled crossing (pedestrian)
Foleshill Road	Toucan crossing on Foleshill Road (inbound) at a point approximately 10 metres north of its roundabout junction with Jimmy Hill Way, to be installed as part of proposed traffic signals, and to replace the existing controlled crossing (pedestrian)
Jimmy Hill Way (A444)	Toucan crossing on Jimmy Hill Way (A444 outbound carriageway) at point approximately 26 metres northwest of its roundabout junction with Foleshill Road replacing and relocating the existing controlled crossing (pedestrian)
Jimmy Hill Way (A444)	Toucan crossing on Jimmy Hill Way (A444 inbound carriageway) at point approximately 9 metres northwest of its roundabout junction with Foleshill Road, to be installed as part of proposed traffic signals, and to replace the existing controlled crossing (pedestrian)
Jimmy Hill Way (A444)	Toucan crossing on Jimmy Hill Way (A444 inbound carriageway) at point approximately 24 metres southeast of its roundabout junction with Foleshill Road replacing and relocating the existing controlled crossing (pedestrian)
Jimmy Hill Way (A444)	Toucan crossing on Jimmy Hill Way (A444 outbound carriageway) a point approximately 8 metres east of its roundabout junction with Foleshill Road, to be installed as part of proposed traffic signals, and to replace the existing controlled crossing (pedestrian)
John Wigley Way	Parallel crossing to be located on John Wigley Way approximately 9 metres southeast of its junction with Foleshill Road

A parallel crossing is a controlled crossing for use by both pedestrians and cyclists. The parallel crossing uses the zebra crossing layout for pedestrians, with a cycle route marked alongside. The proposed parallel crossings should assist both pedestrians and cyclists to cross the road.

The works are part of a scheme to improve cycle facilities and to encourage people to cycle. The works should assist to improve access and safety and be completed by the end of Autumn 2024.
