Freedom of Information Act 2000 (FOIA) Request ID: FOI619788853

Thank you for your request for information relating to developer has yet to fulfil their obligation of paying a commuted sum.

You have requested the following information:

I would be grateful if you could provide me with the following information on all known cases whereby the Developer has yet to fulfil their obligation of paying a commuted sum and transferring the Open Space to the Council.

- a. Site Name/Address of all Unadopted Areas of Public Open Space within the Council's Jurisdiction.
- b. Name of Developer associated with the corresponding site.
- c. Date of the Section 106 Agreement to which the Open Space applies.
- d. The Agreed Commuted Sum Value to be paid by the Developer.
- e. Planning Application Reference(s).

We hold the information which you have asked for, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating,

retrieving and extracting it.

The requested information is held in a nonreportable format which would require an officer to manually records to determine what information is held and collate the relevant data. This will exceed 18 hours work. Your request has been refused under section 12(2) of the Act.

However, in order to fulfil our obligations under Section 16 of the FOI Act to advise and assist you, we advise that we can provide you with information relating to the last ten years.

Over the past 10 years, since 1 April 2013, there are two agreements that contain (as yet) unfulfilled obligations to transfer open space land to the Council and to pay commuted sums for maintenance. The agreements are shown in the table below.
