Thank you for your request for information relating to NowMedical Ltd.

You have requested the following information:

1. In 2023-2024, did the council use NowMedical Ltd to assist in determining priority need for the purpose of making main housing duty decisions?

2. In 2023-2024, did the council use any other medical advice company to assist in determining priority need for the purpose of making main housing duty decisions? What companies were they?
