Thank you for your request for information relating to Cost breakdown of Route 52 cycle path upgrade between Warwick University and Charter Avenue.

You have requested the following information:

The recent press release about the newley completed cycle path update (<https://www.coventry.gov.uk/news/article/5039/upgraded-walking-and-cycling-route-reopens-increasing-local-links-to-coventry-station>) states that it cost £1.5million in grant funding from Sustrans. Could you provide a breakdown of costs, funding, and contractors allocated for this work.

In response to your request, we confirm that Sustrans provided funding through a sub-grant agreement to bring forward cycle connectivity and to extend the existing routes within the area. The funding of £1,504,267 was broken down into two main headings, which consisted of £1,413,891 for construction costs and project management, and £90,376 for ecology works, ecology surveys and biodiversity works.

The final accounts for the works, including legal orders, road space booking, street lighting, utility diversions and final construction costs are still being completed. However, the total expenditure expected for these works to be completed is approximately £1,315,035. The remainder of the costs are expected to be used to cover the design fees associated with this project.

The main contractor for the works was Breheny Civil Engineering Limited with additional input from Yunex (Traffic Signals), Balfour Beatty (PFI Street Lighting) and various utility companies.
