In response to Question 4, the Local Authority commissions various targeted mentoring and interventions services to children and young people.

Outreach and detached provision are largely commissioned by the Violence Reduction Partnership.

Commissioned services by the Local Authority, are in response to specific incidents in the city and are not scheduled on a routine basis per week/times. Funding can be made available through the year (for example, via the Violence Reduction Partnership).

The Community Safety Fund is an annual grant that supports delivery and, this funding from the Police Crime Commissioner; is used to fund mentoring/including outreach mentoring for the contribution to the Youth Justice Service; details of this, is presented on the last published Youth Justice Plan which is available on the following link:
