Thank you for your request for information relating to Information on 0-19 Healthy Child Programme Contracts.

You have requested the following information:

1. A list of suppliers contracted to deliver for your Council's Health Visiting Services (0-5) between October 2015 and March 2024.

October 2015 to August 2018: Coventry & Warwickshire Partnership Trust (CWPT)

September 2018 to March 2024: South Warwickshire Foundation Trust (SWFT), as part of an integrated Family Health & Lifestyles Service.

2. The duration of each contract with these organisations, including the start and end dates.

CWPT: Health Visiting contract was novated to Coventry City Council as part of the transfer of the public health 0-5 commissioning responsibilities to local authorities in October 2015. Contract ran until August 2018 as detailed above.
