Thank you for your request for information relating to MOT Failures.

You have requested the following information:

Under the Freedom of Information Act 2000, I would like to request the following information for the past five years (2024,2023,2022,2021,2020,2019):

## **MOT Failures**

- The total number of vehicles that have failed their MOT test, broken down region and by month between January 2019 and October 2024. If time allows, please provide the regional data by postcode area.
- A breakdown of the most common reasons for MOT failures for tests between January 2019 and October 2024, categorised by defect type (e.g., lighting and signalling, brakes, suspension, tyres, etc.). Please provide the total number of failures for each
- A breakdown of MOT failures by vehicle age, categorised as:
- o 0-3 years
- o 4-6 years
- o 7-10 years
- o 11-15 years
- o 16+ years

## • The number of fines issued for cars without an MOT, broken down by month and region.

In response to your request, we confirm that we do not hold this information and are informing you as per Section 1(1) of the Act, as we do not record this information on our system.

To advise and assist, the Driver and Vehicle Standards Agency (DVSA) are the authority that issue fines and would hold the information requested above.
