Thank you for your request for information relating to Temporary Accommodation Nightly Rates.

You have requested the following information:

1. How many properties do you currently have on Temporary Accommodation?

As at 9 October 2024, there are a total of 1,336 households being accommodated in temporary accommodation. This includes 939 family households and 397 single households (single person or couple with no dependent children).

2. Please can you advise us on the maximum that is paid per night for a Studio, 1 Bed, 2 Bed, 3 Bed & 4 Bed.

The table below shows the maximum amount that the Council pays for temporary accommodation booked on a nightly basis.

1 bed	2 bed	3 bed	4 bed	5 bed
£46.00	£51.00	£57.00	£63.00	£69.00

Please note the above table shows the maximum amounts paid. All properties must meet the expected standard before we will use them as Temporary Accommodation. We work within a price matrix and hierarchy where the providers with lower rates are used first.

3. Who are your largest 5 suppliers and how much do you pay them on average every month and provide the last 3 month they have invoiced you for?

In response to Question 3, we confirm the information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'
