Thank you for your request for information relating to planning applications and biodiversity net gain.

You have requested the following information:

1. How many full planning applications have been made in total since 2 April 2024?

Following careful consideration, the information you requested falls under the exception(s) in Regulation 6(1)(b) of the Environmental Information Regulations 2004, which relates to 'information reasonably accessible to the applicant by other means.'

This exception is not subject to the public interest test.

2. How many of those applications are subject to mandatory BNG (i.e. not covered by the Biodiversity Gain Requirements (Exemptions) Regulations 2024), and please could you provide the application reference numbers for those?
