Thank you for your request for information relating to UASC care leavers.

You have requested the following information:

1. UASC care leavers with no immigration permission

a. How many unaccompanied asylum-seeking child (UASC) care leavers in your local authority were classified as having no immigration permission in 2020, 2021, 2022, and 2023? Please provide a breakdown by immigration status if available.

b. How many unaccompanied asylum-seeking child (UASC) care leavers in your local authority were classified as being Appeal Rights Exhausted in 2020, 2021, 2022, and 2023?

c. How many of those identified in (1a and 1b) received care leaving support in 2020, 2021, 2022, and 2023?

2. UASC care leavers with No Recourse to Public Funds (NRPF)

a. How many unaccompanied asylum-seeking child (UASC) care leavers in your local authority were classified as having leave to remain subject to NRPF in 2020, 2021, 2022, and 2023?

b. How many of those identified in (2a) received care leaving support in 2020, 2021, 2022, and 2023?

We hold the information which you have asked for, but we have estimated that the cost of meeting

your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

The information is not held centrally or within a reportable format. It would therefore require an officer to manually trawl through every relevant child's records to identify, extract and collate the data. Due to the number of records to check, this will exceed 18 hours work.

Your request has therefore been refused under section 12(2) of the Act.
