Introduction

When to use this form

This regime is known as Local Authority Integrated Pollution Prevention and Control, LAPPC. Installations permitted under this regime are known as Part B installations. Use this form if you already have a permit and wish to transfer the permit in whole or in part to another person (the proposed transferee or new operator). You may apply to transfer the whole or part of your permit. Under the Environmental Permitting (England & Wales) Regulations 2010 (the "EP Regulations") both the current operator and the proposed transferee must jointly apply to have the permit transferred and must both sign this form.
