Introduction

When to use this form

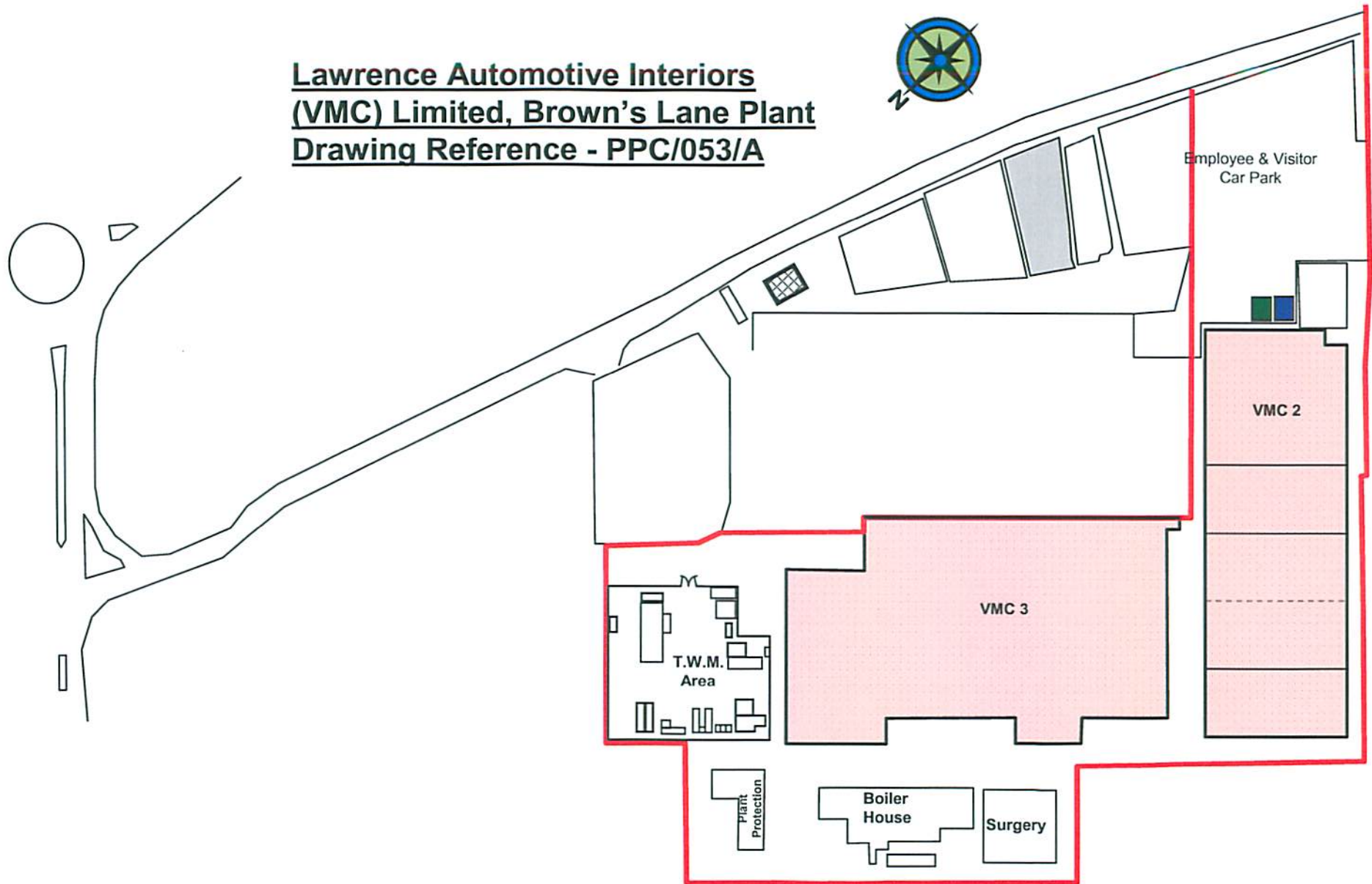

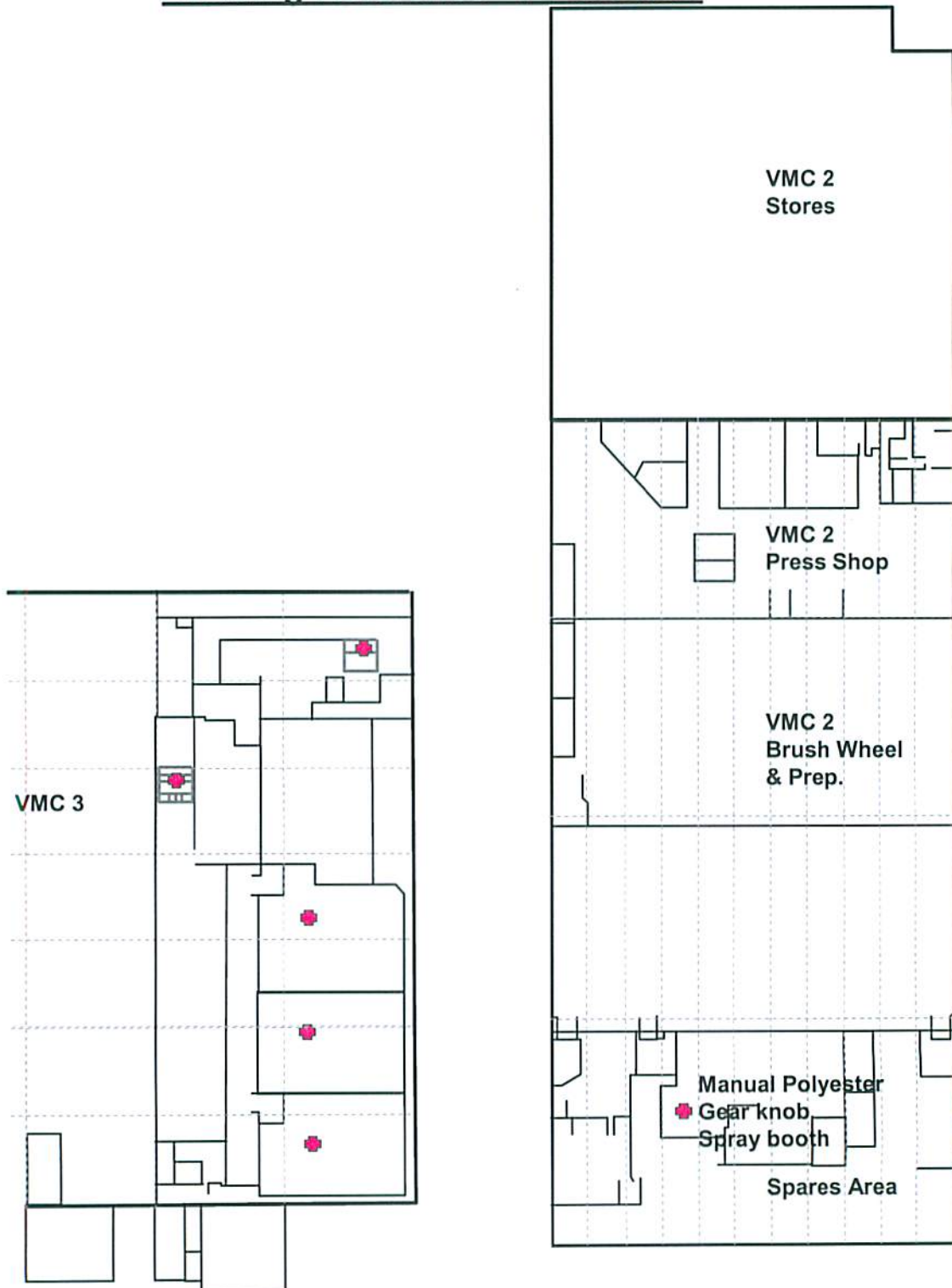

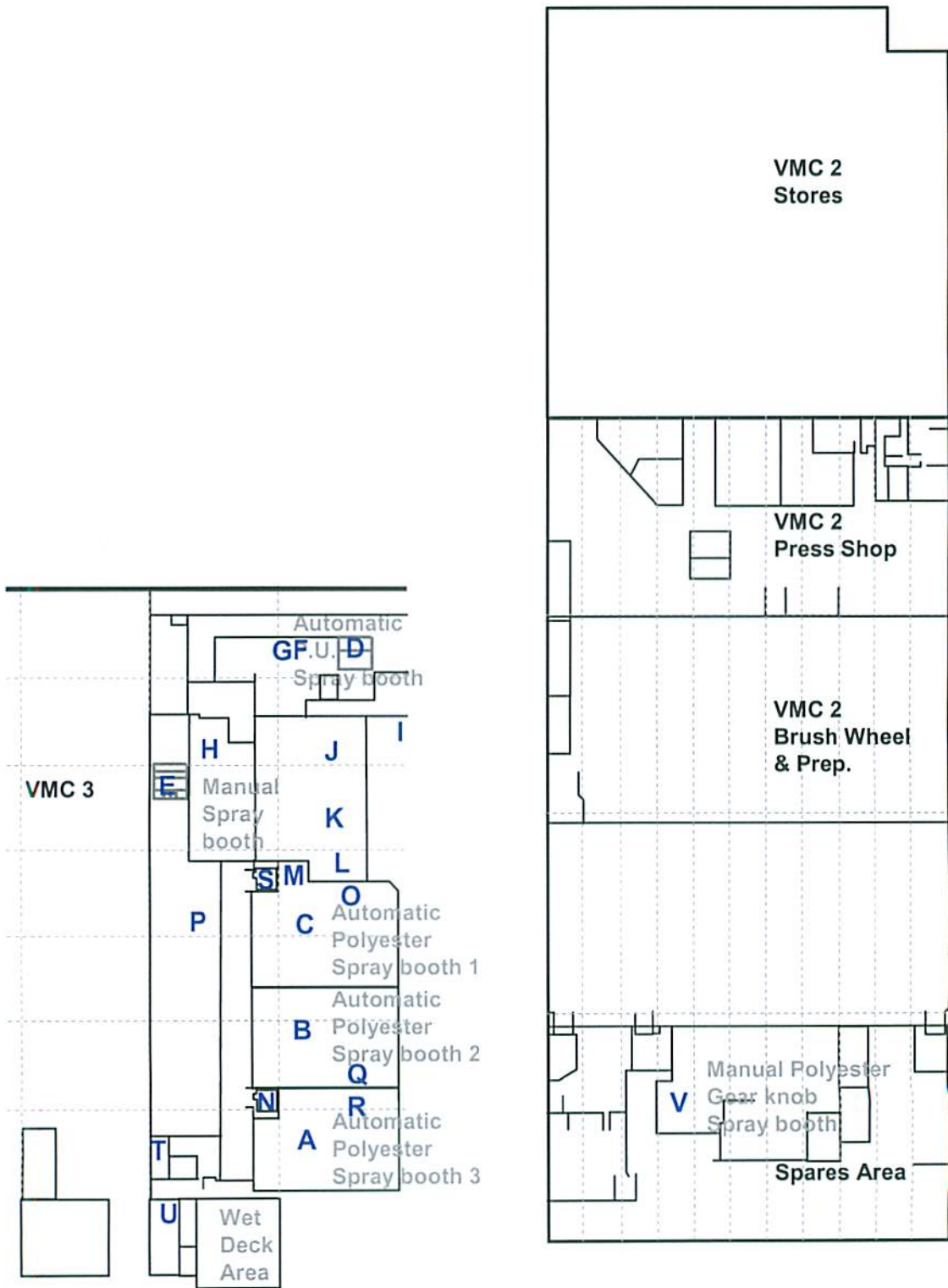


Coating Process Permit – Brown’s Lane Plant
