

**Re: LAPPC Application for Tarmac Limited, Aldermans Green Industrial Estate, Coventry
(application reference PPC 180)**

The Health Protection Agency has received from Coventry City Council an LA-PPC application to operate Tarmac Ltd at Aldermans Green Industrial Estate, Coventry. This process consists of a concrete batching plant.

The main emissions of concern are fugitive dust emissions. As this is a new installation, the applicant has not yet provided any data regarding emissions from this facility. Therefore, it is impossible to make any assessment of the potential health implications of operating this facility. However, we are encouraged to see that emissions from the cement silos are reduced through the installation of filters and stockpiles will be damped down during dry weather.

Due to the abatement systems in place, it is unlikely that there will be any impact on local human health receptors from this installation. However, we recommend that the Regulator ensure that best available techniques are employed so that the emission limits as set out in Process Guidance Note 3/01 (04) (Blending, Packing, Loading, Unloading and Use of Bulk Cement) are met.

Local Health issues

Based on the application, this installation does not present any obvious cause for concern providing it is well managed and maintained. However, if you are aware of any health issues in this area we recommend you inform the Regulator.
